



### SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES 1.

### (a) Method of Accounting

The financial statements are prepared under the historical cost convention, on the accrual basis of accounting and in accordance with the accounting standards issued by the Institute of Chartered Accountants of India and referred to in section 211 (3C) of the Companies Act, 1956. The significant accounting policies are as follows:

### **(b)** Fixed Assets and Depreciation

Fixed assets are stated at cost less accumulated depreciation. The company capitalizes all costs relating to the acquisition and installation of fixed assets. Depreciation on fixed asserts is provided pro-rata to the period of use on the Straight Line Method using rates specified in Schedule XIV to the Companies Act, 1956 which is as follow:-

### **Borrowing Costs**

(e) Income and Expenditure are being accounted for an accrual basis.

Preliminary Expenses are amortized over a period of five years.


